

# **Arts in Harmony 2012**

SEVENTEENTH ANNUAL INTERNATIONAL JURIED ART SHOW

## February 6 - March 29

### SHERBURNE COUNTY GOVERNMENT CENTER

### **Eligibility**

Open to all living artists. Entries must be ORIGINAL work not previously exhibited in an Arts in Harmony show. Inappropriate subject matter (including nudes) is not acceptable. ERAAA reserves the right to determine acceptability.

#### Slides, Photos, or CDs

Entry shall be by slides, photographs, or CDs. Up to three separate views of each 3-dimensional piece may be submitted.

Slides and photographs must have the Artist's Name and Title printed on the back and must indicate the top. Also indicate the screen side of slides if not marked. Slides shall not have tape affixed to them other than silver photo tape on the image area only, and may not be in glass mounts.

Photographs may have a mat or backing and must be firmly bonded together.

Digital images must be in a JPG file no more than 800 pixels on the longest side, formatted to open directly in the proper orientation. Name each image as follows: Last Name\_First Name\_Entry Letter.JPG. Please include identified thumbnail prints of your entries (strictly for office use, not for the jurors).

example: Smith\_Jane\_A.JPG Smith Jane B.JPG

#### **Fees**

\$35 for one or two entries. ERAAA Members: \$30 for one or two entries. An unlimited number of additional entries may be submitted at \$6 per entry, but please note that no more than three entries per artist will be accepted into the show. A \$5 discount applies to entries postmarked by November 15, 2011.

#### Media

Paintings, drawings, digital and hand-pulled prints, mixed media, fiber, batik, photography (not digitally altered or photo of work in another medium), digital (including digitally altered photographs), ceramics, glass, sculpture, and sequential art. No copies, class work, or fragile work.

#### **Conditions and Liability**

Accepted entries must remain on exhibit for the duration of the show. Artists who desire to insure their work must make their own arrangements. The Arts Alliance and Sherburne County cannot be held responsible for loss or damage. All hanging work must be properly framed and have a hanging wire. No sawtooth or photo hangers. Drawings, prints, photos, watercolors, and batik not under glass or plexiglass must be completely fixed to a backing board. Maximum weight of hanging pieces is 15 pounds, and maximum width including frame is 42 inches. Three-dimensional work must fit through a standard door (no installation pieces). The work should have no sharp edges or features that could be harmful to small children. Stands will be provided.

#### **Show Location**

Sherburne County Government Center is located at 13880 U.S. Highway 10 (2-1/2 miles west of downtown Elk River).

#### **Entry Procedure**

Send entry form and slides, photographs, or CDs along with check, money order, or credit card information payable to ERAAA. All entries must be postmarked or hand-delivered by December 2, 2011. Please mail early. Slides will be returned; however, CDs and photographs will not be returned. Return envelope and postage will be provided by the Arts Alliance.

#### **Accepted Work**

All accepted work must have the artist's name and the title of the piece placed on the back, preferably in the upper left hand corner, or on the bottom or lower back side in the case of sculpture. The work can either be hand-delivered or shipped.

Hand-delivered entries - See Calendar.

Shipped entries must be prepaid. See Calendar.

Return shipping charges and a \$10 per box handling fee apply. Do not send shipping fees with entry.

#### Jurying

Approximately 210 pieces will be selected for the show.

Accepted hand-delivered work must be picked up at the Government Center Thursday, March 29, from 4:30 P.M. – 7 P.M. **OR** Saturday, March 31, from 10 A.M. - Noon.

Selected works to be on exhibit in the second floor gallery of the **Thrivent for Lutherans** building in downtown Minneapolis.

#### Juror

Peter Spooner, Curator, Tweed Museum of Art (University of Minnesota—Duluth). With a permanent collection of over 6,000 art objects representing a range of cultures and periods of art history, the Tweed Museum is a major cultural and educational resource of the upper Midwest.

#### Membership

Members may participate without cost in the Members Only Show in the fall and enter the National Juried Show at reduced fees. They are eligible for the members awards, and pay lower commissions on the sale of their art. *Membership does not increase your chances of being accepted into this show.*Memberships start at \$35 per year for your entire household. Check the appropriate box on the entry form, and add your membership to the member entry fee.


#### **Traveling Show**

Work is selected by a panel appointed by the Arts in Harmony chairperson, and may include pieces not selected for awards.

# Arts in Harmony 2012 International Juried Art Show

#### **About The Area**

Native Americans called it "Wich a wan" (where two rivers join). Early settlers built a trading post near the junction of the Elk River and the Mississippi, and called it "Elk River." The county seat for Sherburne County, Elk River is located 30 miles northwest of downtown Minneapolis.

The significant emphasis on high quality arts and culture in the greater Minneapolis and St Paul Area is reflected in Elk River through the Art Alliance, an internationally known Boys Choir, the Community Theater, and two year-round art exhibition programs.

#### The Location

The Sherburne County Government Center is the hub of activity in the area. It is located west of downtown at 13880 U.S. Highway 10.

The large numbers of visitors to the building makes this an ideal place to bring the public to your art, producing above average sales. Space allows for hanging up to 180 pieces of art, with additional area for up to 20 to 30 three-dimensional pieces.

#### Sales

All entries must either have a sale price or be marked not for sale (NFS). No works marked POR will be accepted. The Elk River Area Arts Alliance will retain a 25% commission on sales resulting from this show (15% from members). Prices must include the commission. The Arts Alliance will collect and pay sales taxes.

#### Resumes

Artists are encouraged to include <u>two copies</u> of a current resume or artist's statement. Resumes must not be more than TWO single-sided pages or ONE double-sided page. Resumes of accepted artists will be available in books for patrons to read.

#### Returns

Shipped works will be returned shortly after the show. If a piece was shipped with one selected for the traveling show, both pieces will be returned after the traveling show. Hand-delivered work not picked up at the specified times is subject to a storage fee and can be retrieved only by special arrangement with the Arts Alliance (763.441.4725). After March 31, the Sherburne County Government Center will not have the work or information about pickup.
